MAY 24, 2021
Chairman Helgevoid called the regular meeting of the Wright County Board of Supervisors to order at 9:00 a.m. Members present were Kluss, Rasmussen, and Helgevoid. Minutes of the previous regular meeting of May 17, 2021 and special meeting of May 19, 2021 were read and approved.
Approved claims for payment.
Sandy McGrath with Wright County Public Health gave an update on the COVID cases in Wright County. There is 4 new positive cases since last week with a total of 1,853 since March 2020. A total of 40.7% of Wright County residents have been fully vaccinated. The CDC has loosened the guidelines for wearing masks. You do not need to wear a mask if you have been fully vaccinated. McGrath continues to emphasize to follow the CDC guidelines and encourages everyone to get vaccinated. The Public Health department did go to the Eagle Grove School last Friday and vaccinated 72 students. They have scheduled to go to Belmont Klemme School this week and Clarion Goldfield Dows School.
Mike Christians, private landowner, met with the Board to discuss DD #107 ditch cleanout. He was concerned about sloping the sides to a 2 to 1 slope with working from only one side of the ditch. He has spoken to the engineer on the project and the contractor will be going to the other side to get the correct slope.
Motion by Kluss and seconded by Rasmussen to approve pay estimate #2 for DD #107 ditch cleanout to Reutzel Excavating. Motion carries.
Helgevoid gave an update on the hiring of an Economic Development Director. The Committee met and will be posting the position with applications to be submitted by June 18th in the Economic Development office.
Helgevoid also stated that the Economic Development Board requested to do a payroll adjustment of and additional \$1,000 per month payable to Sarah Holmes for the extra duties she has been doing while the County has been without a Director since March 22, 2021. There was then a motion by Rasmussen and seconded by Kluss to approve the wage adjustment of \$1,000 per month to Sarah Holmes.
Helgevoid then updated the board of the Notice of Annexation to the City of Eagle Grove letter sent to him. The city would like to annex 14.85 acres of land on the North side of Eagle Grove. There will be a consultation meeting on May 26th at 2:00 p.m. in the City Hall.
Courtney Morris, Drainage Clerk, provided the full list of drainage districts to be assessed in 2021. Motion by Kluss and seconded by Rasmussen to approve the list of drainage district to be assessed. Motion carries.
Dennis Mraz and Tim Hamilton with Veterans Affairs Commissioner came to speak to the Board to discuss a wage adjustment for Chris Oliver, Wright County Veterans Affairs Commissioner. She is currently making \$43,929.60 and they are requesting \$10,000 pay adjustment for her effective July 1, 2021. No final action taken at this time.
Adam Clemons, Wright County Engineer, gave an update on road projects. The hauling of rock south of Hwy 3 is completed. With the gravel hauling, Zone 1 north of Hwy 3 is working out of Wright Materials, Zone 2 has 10 mile left which is South of Hwy 3 and Zone 3 has 6 miles left. They are continuing to do shoulder rock on the SW quadrant of the County. There were 16 more work orders completed and the men are gearing up for large scale ditch clean outs. It took about 5 days to complete the 1st round of roadside mowing.
Clemmons then requested that the Board of Supervisors move into closed session with the Drainage Attorney, David Johnson to discuss the property located south of Belmont and a letter written by John Stuebaker.
Motion by Kluss and seconded by Rasmussen to consider going into closed session pursuant to Chapter 21.5 (c) of the Iowa Code to discuss strategy with counsel in matters that are presently in litigation or where litigation is imminent where its disclosure would be likely to prejudice or disadvantage the position of the governmental body in that litigation. By roll call vote: Ayes – Kluss, Rasmussen, and Helgevoid; nays – none. Went into closed session at 10:05 a.m.
Motion by Rasmussen and seconded by Kluss to go back into open session at 10:44 a.m. Motion carries.
Motion by Kluss and seconded by Rasmussen to move forward with Option A as discussed in closed session. Motion carries.
Rasmussen brought up a concern from a text message from a concerned citizens about why there are so many flies.
Motion by Rasmussen and seconded by Kluss to adjourn the meeting. Motion carries.

Eagle Grove Storm Water Discharge

PUBLIC NOTICE OF STORM WATER DISCHARGE
Daybreak Foods plans to submit a Notice of Intent to the Iowa Department of Natural Resources to be covered under the NPDES General Permit Number 2 "Storm Water Discharge Associated with Industrial Activity for Construction Activities".
The storm water discharge will be from construction activities for the Daybreak Foods Offline Breaking project in Eagle Grove, Iowa. Soil disturbing activities will include the following; the removal of an existing gravel driveway, construction of a building expansion, installation of concrete driveways and parking lot, and final grading and seeding. The project is located at the northeast corner of the intersection of IA-17 and 225th Street in Eagle Grove, IA.
Storm water runoff from this site will be conveyed south offsite via one point source. Water will then travel approximately 0.1 miles south and discharge into Ditch Number 4. Runoff will then travel approximately 1.8 miles west and discharge into the Boone River.
Comments may be submitted to the Storm Water Discharge Coordinator, IOWA DEPARTMENT OF NATURAL RESOURCES, Environmental Protection Division, Henry A. Wallace Building, 502 E 9th St., Des Moines, IA 50319-0034. The public may review the Notice of Intent from 8 a.m. to 4:30 p.m., Monday through Friday, at the above address after it has been received by the department.
