#### Wright County Board of Supervisors September 18, 2023

Chairman Kluss called the regular meeting of the Wright County Board of Supervisors to order at 9:00 a.m. Members present were Kluss, Rasmussen, and Helgevold.

Motion by Rasmussen and seconded by Helgevold to approve the tentative agenda. Motion carries. Minutes of the previous regular meeting of September 11, 2023 were read and approved. Approved claims for payment

In open forum, Sandy McGrath, Wright County Public Health Administrator, gave an update on the COVID vaccinations. On September 11, 2023 all previous COVID vaccines were pulled and disposed of In the next coming weeks, the new COVID vaccine will be available at Public Health. McGrath is also advising individuals get their flu shot and anyone over the age of 65 get the RSV vaccination.

Tonee Nicholas, Wright County Assessor, also spoke in open forum. There will be a property appraiser from the lowa Department of Revenue in the county this week looking at a dozen commercial properties. Her name is Lisa Schumacher and she will be in a State of Iowa car #2067. Every two years the Department of Revenue will send an appraiser to the counties that do not see enough commercial sales.

Held the canvass of votes for continuing the EMS Tax Levy for 15 years. The special election was held on Tuesday, September 12, 2023. There were 629 yes votes and 55 no votes. The public measure passes with 92% and will continue for an additional 15 years. Motion by Rasmussen and seconded by Helgevold to approve the canvass of votes for the Special EMS Tax Levy Election. Motion carries. Motion by Rasmussen and seconded by Helgevold to approve Crisis Intervention Services to use the courthouse parking lot on October 28th from 9:30 a.m. to 11:30 a.m. for Trunk-O-Treat Halloween activity. Motion carries.

Kluss had a conversation with the Conservation Director about the Agribusiness Park drainage ditch. Motion by Kluss and seconded by Rasmussen to not employ Joey Harrah to spray the Agribusiness Park drainage ditch and have Conservation spray and clean up the Agribusiness Park. Motion carries. Adam Clemons, Wright County Engineer, gave an update on the Secondary Roads. There were 37 work orders completed last week with 29 being entrance close outs from the applicants. Year 3 scheduled gravel was completed last week Bridge #53 on R59, south of Galt, will be getting formed and pour paving this week. Bridge #137 on 190th Street. between Ida Avenue and Hancock Avenue, has been taken down and hauled new rock as crews put together the pipe. Crews completed

the night drive last week to evaluate the road signs in the county. Motion by Kluss and seconded by Rasmussen to go into closed session at 9:23 a.m. pursuant to Iowa Code Chapter 21.5(1)(j) to discuss the purchase or sale of a particular real estate only where premature disclosure could be reasonably expected to increase the governmental body would have to pay for that property or reduce the price the governmental body would receive for the property. By roll call vote: ayes – Kluss, Rasmussen, and Helgevold; nays - none. Motion

carries. Motion by Rasmussen and seconded by Helgevold to move out of closed session at 10:25 a m Motion carries.

There was no action taken concerning closed session.

Rasmussen spoke on the Agribusiness Park lease. Kluss will talk with the County Attorney on the legal requirements and update the Board next week.
