November 27, 2023

Chairman Kluss called the regular meeting of the Wright County Board of Supervisors to order at 9:00 a.m. Members present were Kluss, Ras-

mussen, and Helgevold. Motion by Helgevold and seconded by Rasmussen to approve the tentative agenda. Motion carries.

Minutes of the previous regular meeting of November 20, 2023 were read and approved.

open forum Tonee Nicholas, Wright County Assessor, stated that Vanguard Appraisal company will be in Wright County December 19 & 20th . They will be reviewing approximately 60 properties those two days along with her staff.

Motion by Kluss and seconded by Helgevold to open the public hearing on a construction permit application for JT Dean/Centrum in Section 18, Vernon Township. Motion carries. Sandy McGrath stated that the proposed confinement feeding operation will be to construct two new chicken egg layer buildings, one new dry manure storage build-ing and one new bio security personnel building at an existing poultry confinement facility. The animal unit capacity of the confinement operation after construction will be 28,000 animal units. (2,800,000 chickens averaging 3 pounds or more) The matrix met a passing score and the county has requested that trees be planted but was not part of the matrix as submitted. There were no public or written in-

put on this facility. There was then a motion by Kluss and seconded by Helgevold to approve the site and close the hearing. Motion carried. Adam Clemons, Wright County Engineer, updated the board that they are blading routes as much as possible. They also conducted a motor grader recovery training. This included having a shop mechanic teach each grader operator on where to hook up to their grader in such an instance that they need to be towed or pulled out. Secondary road employees are done with the mowing of pavements, and are still working on ditch burning and brush cutting. The crews did go out on the 26th of November to sand intersections and hilltops.

Julie Edwards, UDMO Director, presented the annual report for services in Wright County. Upper Des Moines Opportunity, Inc, provided assistance to 2,611 individuals in 1,128 households with a total cost of service \$364,283.79 for Wright County Citizens. Some of the programs they have is LHEAP, food pantries, CHORE Senior program, Weatherization, help with rent to name a few. UDMO is requesting continued partnership and financial support in the amount of \$16,000.00. This will be taken into consideration at budget time. Motion by Rasmussen and sec-
