BOARD PROCEEDINGS
Wright County Board of Supervisors • Jan. 22, 2024

January 22, 2024

Chairman Helgevoid called the regular meeting of the Wright County Board of Supervisors to order at 9:00 a.m. Members present were Kluss, Rasmussen, and Helgevoid. Motion by Kluss and seconded by Rasmussen to approve the tentative agenda. Motion carries. Minutes of the regular meeting of January 15, 2024 were read and approved.

Approved claims for payment. Bob Ritter spoke in open forum about the post hearing reply briefs on the Iowa Utilities Board (IUB) proceedings for the Summit Carbon Solutions Pipeline. Ritter stated that the pumping stations aren't under the permitting process with the IUB. Motion by Rasmussen and seconded by Kluss to receive the quarterly revenue report from the Wright County Recorder. Motion carries.

Peggy Schluttenhofer, Wright County Treasurer, presented the Semi-Annual report. The only concern would be the deposit under the American Rescue Plan Act (ARPA) for the Local Assistance and Tribal Consistency Fund (LATCF). The LATCF was set up under the ARPA fund but with a separate project code. Schluttenhofer will work with the Auditor's Office to possibly make a new fund for LATCF and do a transfer to the new fund. Motion by Rasmussen and seconded by Kluss to receive the semi-annual report from the Wright County Treasurer. Motion carries.

Motion by Rasmussen and seconded by Kluss to approve the payroll adjustment for Jennifer Hogrefe in the Recorder's Office from Clerk to Chief Clerk. Motion carries. The payroll adjustment for Amanda Meyer in the Auditor's Office is tabled to January 29th . Motion by Kluss and seconded by Rasmussen to appoint Darron Baker under Owners of City or Town Property and Todd Swalin under Licensed Real Estate Salesmen or Real Estate Brokers to the Eminent Domain Compensation Commission. Motion carries. Motion by Rasmussen and seconded by Kluss to appoint Alec Amonson as an Eagle Grove Township Trustee. Motion carries. The appointment for Troy Township Trustee will be tabled to January 29th . Adam Clemons, Wright County Engineer, gave an update on the Secondary Roads. There were 21 work orders completed last week with 14 of them using the snow blower and excavator to move troubled areas. Blades were out last week cleaning up from the winter events. Trucks were out checking hard surfaces. Crews were out Sunday, January 14th clearing from the weather event. Trucks were out until 5:00 p.m. Thursday, January 18th , and out at 5:00 a.m. Friday, January 19th with blades out at 7:00 a.m. Duane Asbe with the Wright County Charitable Foundation met with the Board to give an annual update and request funding for the FY 2025. The Wright County Charitable Foundation is requesting \$9,000. This will be discussed during budget discussions. Motion by Kluss and seconded by Rasmussen to adjourn the meeting. Motion carries.

The City of Eagle Grove will be holding a Public Hearing on the 18th day of March, 2024 at 6:30 p.m. The location of the meeting shall be the Eagle Grove City Council Chambers located at 210 E. Broadway in Eagle Grove, Iowa. This Public Hearing is set to review and consider proposals, and if appropriate, approve the disposal and redevelopment of certain City-owned real property – more specifically defined as 724 NW 3rd Street in the corporate limits of the City of Eagle Grove. The City Council will advertise for proposals for the acquisition and redevelopment of 724 NW 3rd Street. A Redevelopment Proposal Packet is available on the City of Eagle Grove's website at www.eaglegrove.gov or by calling City Hall at 515-448-4343. The legal description of the property is as follows: A tract in Outlot 2 of the Auditor's Plat of the Southwest Quarter of the Northwest Quarter of Section 27, Township 91 North, Range 26, West of the 5th P.M., Wright County, Iowa, described as follows: Beginning at the point of intersection of the West line of Outlot 2 and the South line of 3rd Street North, (formerly Johnson Street in the Town of Eagle Grove, Iowa) which point is 340.3 feet North of the Southwest corner of said quarter, thence East along said South

line for 50 feet, thence South for 129.62 feet, thence West for 50 feet to a point on the West line of said Outlot 2, thence North along said West line for 128.8 feet to the point of beginning. Parcel Number: 0927158001
