October 16, 2023

Chairman Kluss called the regular meeting of the Wright County Board of Supervisors to order at 9:00 a.m. Members present were Kluss, Rasmussen, and Helgevold.

Motion by Rasmussen and seconded by Helgevold to approve the tentative agenda with tabling item 12 to review and act on a Construction Permit for JT Dean and also to discuss in new business the debt payments and TIF for the County. Motion carries.

Minutes of the previous regular meeting of October 9, 2023 were read and approved. Approved claims for payment.

In open form, Sandy McGrath, Wright County Public Health administrator, mentioned that flu shots are available at Public Health. They do not currently have the adult COVID vaccine yet.

Jeremy Abbas, Chairman of the

Temporary Redistricting Committee, presented Option 4 of the new 5 Supervisor District plan to go into effect January 1, 2025. The 5 districts will be divided equally with a population for each district of 2,589 and a deviation of +/- 26. Motion by Kluss and seconded by Rasmussen to approve the Temporary Redistricting Committees Option 4 district plan. Motion carries. The documentation will be sent to the lowa Secretary of States office for approval. Abbas, Planning & Zoning Coordinator, gave an update on the setbacks on hazardous liquid pipelines.
