

WRIGHT COUNTY BOS • JULY 22, 2024

July 22, 2024
Chairman Helgevoid called the regular meeting of the Wright County Board of Supervisors to order at 9:00 a.m. Members present were Kluss, Rasmussen, and Helgevoid. Motion by Rasmussen and seconded by Kluss to approve the tentative agenda. Motion carries.
Minutes of the previous regular meeting of July 15, 2024 were read and approved.
Approved claims for payment.
In open forum, Tonee Nicholas, Wright County Assessor, informed the Board that she has appointed Heather Chambers as the Chief Deputy Assessor.
Motion by Rasmussen and seconded by Kluss to receive the quarterly revenue report from the Wright County Auditor. Motion carries.
Motion by Rasmussen and seconded by Kluss to receive the quarterly revenue report from the Wright County Recorder. Motion carries.
Adam Clemons, Wright County Engineer, presented the final payment for FM-C099(102)--55-99, on a project completed last year on C70 and R75. The estimated cost was \$750,000 for the project and the total cost for the project was \$625,815.10. Motion by Kluss and seconded by Rasmussen to approve the final payment for FM-C099(102)--55-99. Motion carries.
Clemons gave an update on the Secondary Roads. There were 7 work orders completed last week. Blade operators were out blading the roads that had water over them. Trucks continue to haul the scheduled gravel with 54 of the 122 segments completed. Clemons wanted to give a reminder that Highway 69, north of the feed mill, is closed for a culvert repair for 4 to 6 weeks. The detour for the closure will take you through Galt.
Dane Pape, with Supplemental Insurance Services, presented a group term life and accidental death and dismemberment quote through MetLife for Wright County Employees. Currently, the Coun-

ty has a term life policy for each full time employee through EMC which will end on August 1st. An additional supplemental policy can be purchased by the employee for their dependents. The MetLife plan does not have an age reduction on the Supplemental Life and will take over those that currently have the supplemental life with no health questions asked. The cost for a MetLife Basic Life Insurance policy for \$50,000 will cost \$11.05/month per full time employee. This rate will be good for just under 2 years.
Bob Powers, with Paradigm Benefits, presented life insurance quotes for 3 companies that were competitive. Of the 3 companies, Hartford stood out to be the best, however, there is an age reduction for both the Basic Life Insurance and Supplemental Insurance option. Hartford will take over those that currently have the supplemental life with no health questions asked. The cost for Hartford Basic Life Insurance policy for \$50,000 will cost \$9.50/month per full time employee. This rate will be good for 3 years.
The Board will hold a special meeting on Wednesday, July 24, with additional information provided from both quotes.
Kluss gave the Board an update on the County Farm water ways and a potential project through the NRCS that may need to be done to the water ways.
Kluss mentioned the new law effective July 1st dissolving the County Compensation Boards. It will be up to the County if they would like to keep the Compensation Boards that set the salaries of the County elected officials. If the Board decides to keep the Compensation Board, there will need to be a resolution put in place to do so. This will be discussed after the ISAC conference in August.
Motion by Rasmussen and seconded by Kluss to adjourn the meeting. Motion carries.
