## Wright County Board of Supervisors October 17, 2022

Chairman Rasmussen called the regular meeting of the Wright County Board of Supervisors to order at 9:00 a.m. Members present were Helgevold and Rasmussen with Kluss absent.

Minutes from the previous regular meeting of October 10, 2022 were read and approved.

Approved claims for payment.

Adam Clemons, Wright County Engineer, presented an agreement between Iowa DNR and Wright County for a Boone River Watershed signage grant. The purpose of this contract is to provide funding from DNR to the County for the construction and installation of 32 primary stream signs, 32 secondary signs, and 2 watershed boundary signs to be installed at designated stream bridges in priority watersheds in Wright County, as identified on the project spreadsheet. Total grant will be for \$8,400.00.

Motion by Helgevold and seconded by Rasmussen to approve contract #23ESDWQBKAMEN-0001 with the Iowa Department of Natural Resources and Wright County for sign grant. Motion carries.

Clemons then presented the Commercial Driver's License (CDL) Training Reimbursement agreement for the board to review. Clemons would like to make some small revisions to the agreement and will put back on agenda at a later date.

Reviewed the lease agreement for office space for Building Fami-

lies at the Wright County Resource Center. Motion by Helgevold and seconded by Rasmussen to approve the lease. Motion carries.

Motion by Helgevold and seconded by Rasmussen to authorize the Auditor to apply for the U.S. Department of the Treasury Local Assistance and Tribal Consistency Fund. Motion carries. Under this program, the county has broad discretion on uses of funds, similar to the ways in which they may use funds generated from other local revenue sources. Specifically, the county may use these funds on any governmental purpose other than a lobbying activity.

Motion by Rasmussen and seconded by Helgevold to receive the quarterly Revenue report from the Wright County Auditor. Motion carries.

Motion by Rasmussen and seconded by Helgevold to receive the quarterly revenue report from the Wright County Recorder. Motion carries.

Denise Baker, Wright County Recorder, requested to do a pay adjustment for employee after a 6 month review. Motion by Rasmussen and seconded by Helgevold to approve a \$1,000 pay increase to Hogrefe after her 6 month review. Motion carries.

Motion by Helgevold and seconded by Rasmussen to adjourn the meeting. Motion carries.
