## Wright County Board of Supervisors • Feb. 6, 2023

### Wright County Board of Supervisors February 6, 2023

Chairman Kluss called the regular meeting of the Wright County Board of Supervisors to order at 9:00 a.m. Members present were Kluss, Rasmussen, and Helgevold.

Motion by Rasmussen and seconded by Helgevold to approve the tentative agenda. Motion carries.

Minutes of the previous regular meeting of January 30, 2023 were read and approved.

Approved claims for payments.

Motion by Helgevold and seconded by Rasmussen to receive the monthly revenue report from the Wright County Sheriff. Motion carries.

Motion by Rasmussen and seconded by Helgevold to approve Resolution 2023-11 accepting the Wright County Compensation Board's recommendation for the compensation schedule for elected officials beginning July 1, 2023. By roll call vote: Ayes – Kluss, Rasmussen, and Helgevold; nays – none. Resolution 2023-11 duly passes and reads as follows:

#### RESOLUTION 2023-11

WHEREAS, the Wright County Compensation Board meets annually to recommend a compensation schedule for elected officials for the fiscal year immediately following, in accordance with Iowa Code Chapters 331.905 and 331.907, and

WHEREAS, the Wright County Compensation Board met on January 12, 2023 and made the following salary recommendations for the following elected officials for the fiscal year beginning July 1, 2023:
