The Temporary Redistricting Commission will be holding a public hearing on May 22nd, 2023 at 11:00am in the Wright County Board of Supervisors Room. The subject matter is the Proposed redistricting of the County Board of Supervisor districts in Wright County from 3 districts to 5 districts. Any citizen may submit comments and/or attend this public hearing concerning the new proposed districts in Wright County. Attached you will find the proposed "5 Supervisor District Map and Description".

Proposed 5 Supervisor District
Descriptions

District #1- Includes the unincorporated Liberty Township that lies West of Davis Avenue. The portion of Boone Township that lies South of 150th St and West of Davis Av-

enue. The portion of Eagle Grove Township that lies West of Highway 17 South to county road C-54. **District #1:** includes the Incorporated City of Goldfield and the incorporated City of Eagle Grove that lies West of Highway 17

District #2- Shall consist of the unincorporated Townships of Woolstock and Troy and Dayton. Eagle Grove Township East of Highway 17 as well as that portion South of County Road C-54 . **District #2:** includes the incorporated cities of Woolstock as well as the City of Eagle Grove that lies East of Highway 17, along with the portion of the City of Clarion that lies West of Lee Avenue.

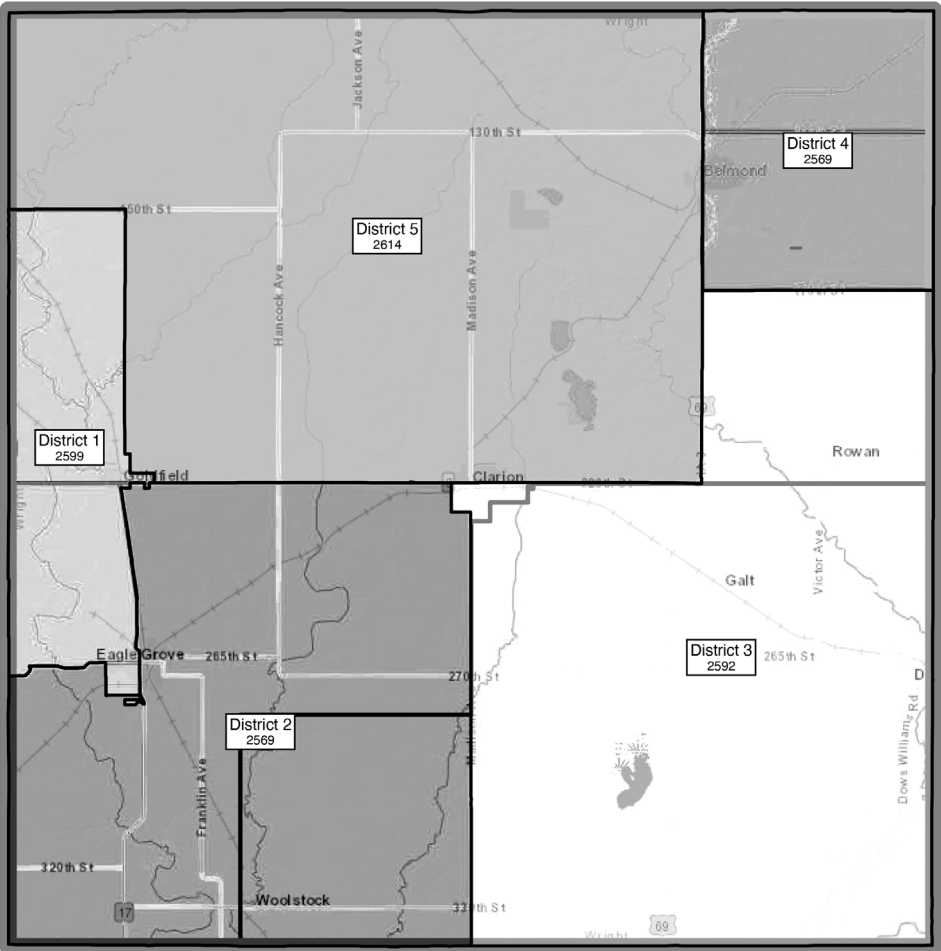
District #3- Includes the unincorporated Townships of Vernon, Wall Lake, Blaine and Lincoln. The portion of Iowa Township that lies South of 170th St. **District #3:** includes the incorporated Cities of

Galt, Rowan, the portion of Dows that lies within Wright County and the City of Clarion that lies South of Highway 3 and East of Lee Avenue.

District #4- Shall consist of the unincorporated Township of Pleasant as well as the portion of Iowa Township that lies North of 170th St. **District#4:** includes the incorporated City of Belmond that lies East of Highway 69

District #5- Shall consist of the unincorporated Townships of Belmond, Norway, Grant, and Lake, along with the portion of Liberty Township that lies East of Davis Avenue. Shall include the majority of Boone Township excluding West of Davis Avenue and South of 150th St. **District #5:** includes the incorporated City of Belmond that lies West of Highway 69 as well as the incorporated City of Clarion that lies North of Highway 3.
